4a (Code:) (Expenses \$ 270,849. including grants of \$ 194,745.) (Revenue \$) Maintenance: The Foundation made its regular annual grant for Arboretum maintenance and renewal to the University of Washington Botanic Gardens to support the Arborist program and the Pacific Connections Gardeners.

4b (Code:) (Expenses \$ 183,008. including grants of \$ 93,612.) (Revenue \$) Education: The Foundation exists primarily to support the Washington Park Arboretum. To this end the Foundation provides volunteer opportunities, educational materials and funds for the K-12 programs.

4c (Code:) (Expenses \$ 236,090. including grants of \$ 53,002.) (Revenue \$ 64,261.) The Foundation also hired staff to coordinate the volunteers stewards program for Pacific Connections and Azalea Way. We supported advocacy in connection with various Arboretum issues. Plant donations nursery and the Pat Calvert greenhouse have volunteer programs to provide ongoing education and skills training in horticulture. Volunteer unit 86 provides docents to the Japanese garden.
